# About Co:3 Australia

Based in Perth, Western Australia, Co:3 Australia is the State's premier contemporary dance company, resident dance company at the State Theatre Centre of Western Australia. Driven by excellence and collaboration, Co:3 Australia is a contemporary organisation, generating contemporary conversations through dance.

We employ a stable of leading Australian artists, including choreographers, dancers, teaching and creative artists, to present an annual mix of main-stage and major performance seasons, studio presentations, community performances and creative development showings.

Our annual performance and development programs deliver high-impact, contemporary dance experiences to audiences locally, nationally and internationally, and deliver strong artistic experiences with and for young people – the new generation.

#### **Engagement Philosophy**

As a company, Co:3 prioritises programs for young people that support their growth as creative, innovative, and entrepreneurial, equipping them with transferrable skills for life in the 21<sup>st</sup> Century and progressing their holistic personal development.

Central to Co:3 youth and education engagement, is the creation of a positive risk-taking environment that builds resilience, grows self-confidence and interpersonal communication skills, and develops leadership potential in all participants.

### Act-Belong-Commit Co:Youth Ensemble

Co:3 offers Act-Belong-Commit Co:Youth Ensemble for aspiring young dancers aged 7-18 years to extend their creative and technical development in dance. Participants will immerse themselves in creative collaboration, choreography, performance skills and improvisation techniques.

The Act-Belong-Commit Co:Youth Ensemble program includes weekly Sunday Co:Sundays, taught by some of WA's leading teaching artists and national and international guests. Under guidance of Co:3's professional dance artists, Co:3 also provide opportunities for participants to create and perform their own choreography, learn existing Co:3 repertoire, and develop site-specific works.

## Registration

Registrations online via the Co:3 website. Registration forms must be completed prior to commencement of the program. Please register before <u>Friday 4 October 2019.</u>

### Uniforms

Participants are asked to wear comfortable dance gear (i.e. leggings and t-shirt/singlet). No specialist footwear is required. Socks or bare feet is fine.

Included in fee is Co:Youth uniform t-shirt, which can be worn to Co:Sundays, rehearsals and other events as required. Please indicate sizing when completing registration.

#### **Participation Fees & Payment Information**

There is a fee to participate, which can be paid in full, or through direct debit instalments (i.e. weekly, fortnightly or monthly payments).

For all recurring instalments, Co:3 processes Direct Debit plans through PayWay Recurring Billing. PayWay is a simple, secure automatic direct debit payment method. If you opt to pay via payment plan, Co:3 will be in contact with you to organise authorisation forms and arrange a mutually agreed instalment plan. Please note that an administration fee will apply\*

For payments in full, the preferable payment method is direct bank transfer, however, cash and cheque payments will also be accepted and must be in a marked envelope with participant's name. Credit card payments accepted over the phone during office hours.
